****Vendor Guidelines and Requirements****

1. Please provide a valid email address for communication. Check daily for updates.
2. No outside food or drinks are permitted to be sold at any vendor table. Water/Ice and personal food is allowed.
3. Vendors should be fully contained, equipped with everything they need to operate. Vendor tables must be always manned. GAGOP will not be responsible for any items taken or left at vendor tables.
4. Set-up begins at NOON and all vendors must be ready by 2:00 p.m. No late set-up or set-up after 1:30 p.m. NO EXCEPTIONS. No refunds for those arriving late and not permitted to set up after 1:30 p.m.
5. Vendors are responsible for ensuring their area is clean and free of trash or other items before leaving.
6. Audio amplification equipment is not allowed in vendor areas.
7. Professionalism and courtesy are expected in interactions with guests, fellow vendors, GAGOP staff and volunteers. Any aggressive or inappropriate behavior towards guests, staff, or volunteers will be addressed by **GAGOP staff**. Vendors who do not adjust their conduct as requested may be required to close their booth. Vendor may return at the end of the event (10:00 p.m.) to pack up booth items. GAGOP is not and will not be responsible for items left at any booth when booth personnel are removed from premises.
8. The event hosts reserve the right to approve or decline any vendor applications and may prohibit future participation for those exhibiting poor conduct or unsafe practices. No refunds for any paid application.
9. Vendors are responsible for any damage they cause to the buildings and grounds. It is required that appropriate fire extinguisher equipment be available at your booth throughout the event if applicable.
10. Waste Management: Vendors are responsible for disposing of their waste, as there are no facilities for grease or gray water disposal at the event. Water or ice is not provided. A dumpster will be available for general waste disposal.
11. Items not permitted include but are not limited to alcohol, nude or semi-nude posters and products, drug paraphernalia, obscene items, fireworks, cap guns or any items that endanger the public or the premises. Sale of non-approved items may result in immediate expulsion with no refund of application fee.
12. Vendor should use all reasonable efforts to market and promote the Event, including promoting on social media platforms on which the Vendor has a presence.

****Fees and No Refund Policy****

1. Payment Process: Payment is required at the time of application submission. We accept various forms of payment, Checks made payable to **Georgia Republican Party** or payment by link (provided after application submission). No space will be assigned without payment. No exceptions. We do not "hold" a space. Space first comes, first paid and first assigned.
2. **No Refunds under any circumstances. This includes no shows, expulsion, vendor placement, other vendor, volunteer, staff problems or concerns etc.**

****General Release****

The undersigned, both individually and on behalf of the Company/Organization, hereby discharges, releases, indemnifies, and holds harmless the City of Perry, Georgia International Fairgrounds and Agricultural Center, Georgia Republican Party their employees, agents, officers, and any GAGOP volunteer from any and all actions, suits, damages, or claims of any kind arising from any loss or damage to the person or property of the undersigned, as well as the undersigned's employees, volunteers, representatives, or agents, while in possession of vendor space or participating in the GAGOP event. The undersigned acknowledges that the vendor fee is non-refundable under any circumstances not expressly outlined in this release. The undersigned further confirms that they have read all rules pertaining to this contract and agree to comply with them. This General Release shall be governed by and construed in accordance with the laws of the State of Georgia. The vendor confirms that the information provided in the vendor contract accurately represents the services and products they will offer at the event. The vendor acknowledges that failure to comply with the terms outlined in the vendor permit will result in disqualification from this and future events. Additionally, the vendor agrees to adhere to all conditions of the vendor permit for this event and to hold harmless and indemnify the City of Perry, Georgia International Fairgrounds and Agricultural Center, Georgia Republican Party against any claims related to their use of vendor space and participation in the GAGOP event. Checking "I agree" on the vendor application signifies that you have read, understand and agree to the terms above.

Contributions to the Georgia Republican Party, Inc. are not deductible as charitable contributions for state or federal income tax purposes. Individual contributions not exceeding federal limits will be deposited in the Georgia Republican Party, Inc. federal account. Corporate contributions will be deposited in the Georgia Republican Party, Inc. non-federal state account. Corporate contributions to the Georgia Republican Party, Inc. federal account are prohibited under federal law. Contributions to the Georgia Republican Party, Inc. federal account are limited to \$10,000 per individual and \$5,000 per multi-candidate PAC per calendar year. Contributions from foreign nationals are prohibited. A copy of our report is available from the Federal Election Commission in Washington, DC and from the Georgia Campaign Finance Commission in Atlanta, Georgia. No federal officeholder, candidate or agent thereof is soliciting any contributions above the federal limit of \$3,300 per individual or \$5,000 per multi-candidate PAC or is soliciting funds from corporations, labor organizations or other federally prohibited sources.
